6 pm Mayor Susan Juschka calls meeting to order and asks everyone to stand for the pledge.

Commission report:

Dan- updates on water project. Concrete work and one fire hydrant are all that is left. Update on master plan and the progress we are making and a few changes in the report and then we will post and advertise the status repot when it is scheduled. Dan also brings up a question for Heather about mowing lawns. Dan asks about badger estimates and suggests that we make an inperson appearance to get an estimate. Dan reminds Steve to replace the pressure gauge on the Downey well pump.

Susan- thanks everyone for their part in Glendo days and voices her appreciation to everyone for attending and helping. She lets everyone know about Dave and Pams thank you to everyone as well.

Tristany- tells everyone that we are taking our tests again and mentions looking into grant writing courses for Kelsey.

Old business

Dave Coffey updates us all on the warren water project and lets everyone know what we found and where we will be progressing as we near the end of the project. He voices his excitement in

the town moving in the right direction with getting lines replaced and names the last few things to wrap up the project. He asks if anyone has any questions. No one does. Josh Miller with WyoDak thanks the town for the patience during the project and thanks Coffey engineering for helping things go smoothly. He talks about a few options we may have for the roads until we can get funding for asphalt. This will be outside the scope of the grant, but the town will be looking into these options.

Derek Wilson Permit is tabled because he was not able to make it.

Vender ordinance-Eric explains the changes made for farmers markets and the verbiage changes. Current health and or food safety certificate if applicable was added to the ordinance. Also added to dispose of their own trash at end of day and added that farmers market fee is for the entirety of the season. Kelly asks if each person needs to apply for a merchant or if one person can on behalf of the entire farmer's market.
